His mother also takes back music discs and books from the white family, which gives him the opportunity to learn about music and paves the way for his future development. As a result, Ellison dose not overstate the hatred between blacks and whites in his work.

Raffle Ellison receives a scholarship to study music at school, but because of money problems he leaves school in his third year at university to earn money. With the help and influence of people like the famous black poet Langston Hughes and the novelist Richard Wright, he begins his own literary journey. In 1952, he publishes his novel "Invisible Man", which is written over seven years.
