In February 2016, The State Council issued the Outline of the Strategic Plan for the Development of Traditional Chinese Medicine (2016~2030), proposing the development of TCM health tourism services.^[2]

We will promote the organic integration of TCM health services and the tourism industry, and develop TCM health tourism with TCM cultural dissemination and experience as the theme, integrating TCM recuperation, rehabilitation, health preservation, cultural communication, business exhibition, TCM scientific research and tourism. The support of national policies makes the integrated development of multiple industries full of opportunities, but it still faces multiple challenges such as shortage of talents, imperfect facilities and uneven service level.

1.2. Significance of studying

2. The current development status and significance of TCM

Second, the role of traditional Chinese medicine in the development of characteristic agriculture: for example: in recent years, Henan Hui County adhere to the party lead, lead the development of Chinese herbal medicine planting as an important gripper, make use of geographical ecological advantages, built 600 mu of golden silk chrysanthemum industry planting base, the construction of the village the drying workshop and drying field, registered hui river longwan trademark, and signed a contract with any industrial co., LTD., through the electric business platform sales floor village river longwan brand of agricultural products. Based on the advantages of regional resources and industrial foundation, it has expanded the planting scale of Chinese medicinal materials, extended the industrial chain to produce great economic and social benefits, enhanced the added value of the industry, cultivated the brand value, and become a leading industry to consolidate the achievements of poverty alleviation and boost rural revitalization. The integrated development model of "Party building + industry + health care" has been gradually improved, driving the increase of farmers' income with characteristic industries and boosting rural revitalization.

Traditional Chinese medicine has unique advantages in the characteristic agriculture, planting and processing according to local conditions. In the whole process of planting, breeding and processing of traditional Chinese medicine, local farmers and TCM experts can provide appropriate planting and

breeding technologies according to the natural environment and geographical characteristics of different regions, adjust the agricultural industrial structure, promote the development of characteristic agriculture, and increase farmers' income to boost the integrated development of traditional Chinese medicine culture and tourism.

TCM home stay can not only provide tourists for health vacation.^[4] In addition, we can cooperate with local farmers and fishermen to innovate and develop TCM experience tour and TCM food tour, so as to help the development of local rural home stay industry and increase farmers' income.

However, there are many problems in the integration of TCM health service and tourism industry, such as insufficient market segmentation and product development depth; governments at all levels and medical and cultural tourism need long-term consultation and cooperation to promote the positive development of industrial integration; TCM + tourism professionals, it is urgent to study and cultivate such compound talents to meet the surging demand of this emerging industry.

3. Traditional Chinese medicine power, the significance of cultural tourism and health care industry

3.1. Promote local economic development

The National Health Commission held a press conference in Beijing on August 17,2023 to introduce the fourth China (Gansu) Traditional Chinese Medicine Industry Expo.

In addition, in terms of TCM tourism, health and other industries, the region plays the advantages of TCM cultural resources such as "medical ancestor" and Huangfu Mi, "ancestor of acupuncture", to promote the deep integration of TCM culture and TCM health tourism. Through the construction of national traditional Chinese medicine health care tourism innovation zone in southeast Gansu, the province has built 31 traditional Chinese medicine health care and leisure tourism.^[5]

In the development process of the TCM industry cluster in Gansu, it has increased the income of local farmers, improved the living standard of local farmers, satisfied the pursuit of a better life as much as possible, promoted the economic development of local rural areas, and helped the implementation of the "all-round well-off society". In addition, TCM industry is a low pollution and low emission industry. The development of TCM is conducive to the implementation of the local "clear water and green mountains are golden mountains and silver mountains", which is conducive to reducing local agricultural water and soil pollution, and improving the local ecological environment.

3.2. Help the diversified development of the rural excellent culture

In recent years, a village in Henan Province of China has been planting traditional Chinese medicine (TCM) in combination with other villages, making contributions to the local rural revitalization through the inheritance and development of local TCM industry culture, such as TCM planting, processing, scientific research, tourism project integration and other innovations.
