China's economic fundamentals still have considerable room for manoeuvre, resilience and growth, which is very worthy of recognition. With the efforts of industrialization and urbanization to further promote high-quality development, the potential of China's economy should be fully stimulated. Therefore, on the one hand, by improving the level of urbanization, we can create consumption demand, drive investment growth and promote economic service, and realize the benign interaction between economic development and sustained expansion of domestic demand. On the other hand, speeding up the reform of household registration system will transform migrant workers from "urban population" in statistical sense to consumers with undifferentiated citizenship. Appropriately increase the amount of business guarantee loans, increase the proportion of discount interest funds of the central government for business guarantee loans in areas seriously affected by the epidemic, and lower the threshold for small and medium-sized enterprises and self-employed individuals to apply for business guarantee loans. At present, China Development Bank and Export-Import Bank have indicated that they intend to issue special bonds for epidemic prevention and emergency financing, and should continue to push policy banks to take similar measures in the future.

3.2 Establish a New Strategy of Global Economic Cycle

After China's economic development has entered the "new normal", to achieve sustainable economic development, it is very important to explore and formulate new strategies for China's economic development according to the new changes in the international economic structure. On the one hand, China should further deepen its economic reform in an all-round way, continue to tap the institutional potential, and demand dividends from the reform. In view of the intention of the United States and other developed countries to pass on responsibilities and risks to China through "global economic rebalancing", instead of responding passively, China should actively participate in relevant international coordination and resolve pressure by gaining more right to speak and make rules. Win strategic initiative; By strengthening economic cooperation and ties with countries all over the world, developing countries will be enhanced in their strategic position in the G20, and the overall strength of Asian countries including China and other developing countries will be enhanced to promote the sustainable development of the world economy.

3.4 Enrich the content of foreign exchanges according to the new changes in the pattern of international relations

The traditional political and military forces, as well as the current economy, science and technology, culture, national system, values and other factors are all influencing the formation of the new pattern of international relations. Actively participate in and promote the solution of global and international hot issues. Global issues and international hot issues are contradictions and difficulties that mankind faces together. The process of solving these problems is a duel between countries, especially big countries, and a process in which countries exert their influence and talents and show their strength and status. At the policy level, China should actively promote the rationalization and improvement of the international monetary system, accelerate the internationalization of RMB, strengthen regional cooperation in currency, strengthen the international coordination of various economic policies and mechanisms, and promote the improvement of international mechanisms to promote balanced global development. Developed countries should be more actively invited to participate in the construction of AIIB, and jointly promote the improvement of global infrastructure and interconnection and development. Facing the rich and diverse influencing factors, if we want to make our country invincible in the competition and at the same time effectively safeguard our national interests, we need to enrich our diplomatic content and enrich our diplomatic foundation in the changing pattern of international relations. At the same time, it creates conditions for promoting the coordinated development of China's own economy and striving for initiative and even leading power in the reshaping of the international division of labor system.

The globalized world will not disappear, but it will become something else to a great extent. Like any over-development trend, globalism will be restricted by people's objective needs, because the latter has better realized the advantages and disadvantages of this theory. We will not bid farewell to the globalized world, but will live in it in another way.
