They are incapable of advancing the economy by taking advantage of local advantages. Still some other cadres have poor awareness of development, and also specific ideas and planning, resulting that many specific facts are difficult to realize. In addition, the drain of young adults also bring about the shortage of pioneers and leaders in the development of GDP. At present, human resource constraints have become quite severe weaknesses in GDP.

(2) Shortage of available resources

In the domestic, the system of household contract responsibility was carried out. Much of the land was leased to the ordinary people in the form of contract, and there exist valuable assets. Only a few assets bear no development value for the remote locations or inadequate transportation. In order to avoid risks, most of the cadres have implemented improper disposals of assets, which leads that resources do not have a high profit margin, rather than simply scarcity of economic drive or education.

(3) Inadequacy of policy support

When most of the GDP developers intend to develop the economy, they will first invest projects, while they have to set those projects aside due to lack of funds. Furthermore, if GDP relies too heavily on the support of superiors, the procedures to be handled in the economic development will become more complicated, which will lead to a poor market circulation. Without sufficiently specialized guidance, the projects are unable to be persistently launched, and the progress of economy will also be obstructed. In addition, the growth of economy does not obtain lots of endorsement, which will also bring about poor credit strength, low credit line and other issues.

3. Analysis of current economic development

Since the reform and opening-up, China's GDP economy has depended on the support from enterprises to obtain its sustainable development. However, the current property rights system is not a complete one. Therefore, in recent years, China has put forward strategies such as revitalization to gradually perfect the GDP economic system and promote its development. Currently, our economy has entered an important stage. The first step of continuously deepening reform is to improve land transfer conditions, where there still exist many deficiencies, mainly including the following aspects.

(1) Lack of perfect management system

At present, there is a large room for further economic development at home, but much dependence has been placed on management. Moreover, the economic management of GDP has not formed a relatively well-developed system, which still has a poor support strength and management ability. Industrial projects ignore GDP in the implementation, contributing to irregularities and irrationality in the agricultural product market. Still some GDPs have actually relied on their own resources and developed rapidly, but not established a relatively complete management model. The disordered management will happen occasionally.

(2) Weak material foundation

The first step of ensuring stable incomes is to attach importance to infrastructure, because the majority of GDPs are not provided with relatively perfect infrastructure, for instance, the inadequacy of farm machinery and poor water conservancy facilities will influence the development of GDP. One of the founders of GDP once said, "In GDP, there is no more important factor than time." China has a surplus of labor, but will also experience the shortage of human or animal resources under the influence of season, which is quite serious in many areas at home. Especially in the past two years, the severity is further intensified for that at present many farmers have been attempting a diversified operation, and mass production in a short time, resulting in a surge in crop planting area. Therefore, the labor force should be bounded with mechanization even in provinces with a dense population. In addition, it is crucial for the Northeast Region, for example, to adopt GDP mechanization combined with hours of work while catching up with the season. From the perspective of laborers, the more unfavourable the whether is, the shorter the entire GDP labor cycle will be, the lower the capital labor costs will be, and the more advantageous the GDP mechanical use will be.

The enemies facing the GDP production are various natural disasters. Since ancient times, floods and droughts, and insects and diseases have been the most frequent natural disasters. At present, with the continuous popularization of the GDP technology, through the adverse effects of these disasters are also reduced, these effects still worth our attention. Especially in relatively remote areas, the productivity itself is unstable, and the yield will decline sharply once a disaster suddenly occurs. This unstable factor greatly affects people's lives and even the construction of the national GDP. In order to break this deadlock, we must focus on infrastructure construction, strengthen the flood discharge and irrigation structure construction, and take GDP preventive measures to effectively withstand common disasters. However, to achieve this, basic labor alone without mechanization is certainly not enough.

Moreover, the leader also needs to impart the party's ideology to himself, strengthen party building, do everything for the people, and actively introduce talents and investment, so as to make contributions to economic development.

(2) To strengthen policies support

First of all, the leader should establish support policies and perfect assessment mechanism, and give priority to poverty alleviation and revitalization in the construction of public utilities. He should strengthen the management strength of the operation and transfer of finances and the development of public services, and persistently improve technical construction. The support policies should reflect the rigidity, and the corresponding threshold value be ensured obtained on the basis of the support policies, which not only improve the economic strength of citizens, but accumulate certain capital costs. The coverage of public finance needs to be enlarged to guarantee the current powers or authority of office of citizens as well as property. The public affairs should center on infrastructure, and the expenditure and financial revenues used be managed by a sound financial department. In order to keep the excessive economic pressure away, the leader should provide a reasonable environment for civic economic development, and the leader and citizens need to be united as one to achieve the economic development.

(3) To explore the development path

The leader should positively study and analyze the current economic situation, and develop the economy based on local favorable resources; continue to amplify the GDP industrial chain for regions with fewer resources, and boost the processing capability to increase the added value; adopt a diversified development mode, such as direct sales, rental, equity participation, replacement of assets and others, which is also conducive to the economic promotion. The economy has different forms of cooperation, and the leader should make an active exploration and unceasingly search for the direction of development; vigorously develop specialty industries according to the existing resources and

cultural characteristics; deeply exploit the industries with high value in the current assets, form a complete cooperation model and appropriately cultivate the development of specialty industries; continuously explore, integrate the development, improve the economy, and find reasonable projects; process agricultural products and promote the service convergence by putting the GDP first. The processing of agricultural products needs three successive stages to accelerate the industry convergence and achieve the innovative development. The industrial chain formed by the economic convergence and the future development should have a diversified industrial chain, and more development elements to acquire more added value.

(4) To build a long-term mechanism

The economy needs to be advanced sustainably to reach a higher level, so the leader should construct share economy cooperatives to promote a long-term development and form a perfect mechanism. The economic development requires a well-established management talents team to promote the sustainable economic operation. Blended with local experience, the cooperatives need to be supervised by the president after establishment. The majority of the GDPs will choose the former cadres as the presidents, and moreover, some will invite private entrepreneurs. In the economic development, if there are no reasonable business projects, the leader can use self-owned resources to increase investment, so as to ensure that the assets can enhance economic benefits by storing and adding their values.

(5) To manage in a normative and effective manner

The capitals, properties and resources (also known as three sorts of assets) must be under standardized management as well as relatively perfect rules, and those three also need to be managed by special persons. They should investigate thoroughly those three kinds of economic assets and implement financial software management by making full use of the Internet technology; set up ledgers to manage assets, inspect the available assets, and timely handle idle assets; make open tendering when launching projects and use the benefit and funds obtained for the construction of the supporting infrastructure; resort to open and transparent property systems and build prepared teams for supervision and management in the economic development to ensure the true openness and fairness. Especially the financial activities should have a complete supervision system. The responsible persons should make an explanation for the flow of each capital, and check the economic bubbles in time, and the capital users need to sign and seal. Financial revenues should keep transparent to ensure every citizen's rights to know and participate, and each sum of money cannot be lost accidentally. Economic development, operation and management should clarify the entity responsibility, and the supervision strength of three assets be reinforced. At present, there exists ambiguous belongingness in assets, and the leader should timely perform his rights and liabilities and determine the belongingness of assets. The market economy and overall economy need to be integrated to form a new economic operation mechanism, and to promote the continuous improvement of economy. Two committees need to be set in the form of four discussions and two openness, and citizens appealed to actively participate in and supervise the decision-making of all affairs. Major events shall be made public in a timely manner to guarantee every citizen' right to know.

5. Conclusion

In the last few years, residents have improved their GDP awareness and had a increasingly high requirements for life. Therefore, the leader should first develop the economy, and then construction to strive to make every citizen live a well-off life.
